This is in continuance of the charge-sheeted/show cause notice dated 7-2-2017 issued to you and the inquiry held in pursuance thereof. As a result of the inquiry the undersigned is satisfied that the charges leveled against you amply proved. I am in the receipt of the Investigation Report of Inquiry officer Mr. Mohammd Aftab Alam, Administrative officer, MRO-II. The report placed before me with statements and supportive documents

The designated official having gone through all the relevant documents and reply submitted to show cause notice issued on 7-2-2017 to you, did not find the said reply satisfactory. Upon read-through of the statements of officers related to case and report of vigilance department MRO-II, I find that Mr. Jitendra Bhoj, while working as an agent at Bandra DO-142400 under MRO-II of The New India Assurance Co. Ltd. having its registered & corporate office at 87, Mahatma Gandhi Road, Fort, Mumbai-400001, during the year 2012-2016 violated the code of conduct for agents as per IRDA "Guidelines on Appointment of Insurance Agents - [2002/2015] section 42 of Insurance act -1938 and other directions issued by authority from time to time by the way of circulars and amendments. I am of the opinion that your services shall be close down to act as an Insurance agent of our company. In this circumstances we are not allowing you to hold agency license issued by the company. Hence your agency **LICENSE NUMBER 6069172659 stands cancelled** with the date of the order. You are instructed to surrender Photo Identity card and original appointment letter to office in charge.

Further as per provisions of the act, you can appeal to the Appellate Officer **within 45 days** of the issuance of order.
