Sealed tenders are invited from authorized agencies have Maharashtra Fire Services license, to undertake refilling of 5 Kg Clean Agent ceiling mounted Automatic fire Extinguishers installed at various locations at our Head Office premises at Mumbai subject to following terms and conditions:

- 1. The Agency must have Maharashtra Fire Service License and a documentary proof in lieu of same must be submitted with Technical Bid.
- 2. Tenders shall be submitted in 2 Bid system.
- 3. In total 37 extinguishers are to be refilled. It will be not in one go, 1st lot of 18 extinguishers are to be refilled and only after installation of refilled 18 extinguishers at their locations, 2nd lot of 19 extinguishers are to be taken out for refilling.
- 4. No transportation/ freight charges on this account will be paid.
- 5. The agency will not be allowed to revise the quote &/or change any extra amount for any other work like for fusible bulbs etc. after work order is issued as per their quoted rate.
- 6. The agency must have at least 5 years' experience in refilling and pressure testing works.
