1. The offer should be submitted in two separate envelopes containing technical and price bids, put together in a 3rd envelope which should be addressed and submitted to

a) Envelope No.1- (Page No. 1 to 5)

It should contain the signed terms and conditions and a DD in favour of "The New India Assurance Co. Ltd." payable at Mumbai 10% of RESERVE PRICE of each Vehicle. The cover should be superscribed as **"Technical bid".**

b) Envelope No.2 (Page No. 6 & 7)

It should contain the price against each car duly signed by the bidder. The cover should be superscribed as "**Financial bid**".

c) Envelope No. 3

It should contain SEALED 1st and 2nd envelope. This cover should be superscribed as 'Quotation for auction of cars' along with bidder's Name, address and contact number. Email may also be provided.

- 2. The DD/ Banker's cheque should be in favour of The New India Assurance Co. Ltd. issued by a Nationalized Bank / Scheduled Commercial Bank and shall be payable at Mumbai.
